Inaugurated in December 2000 at the World Summit of the Arts and Culture in Ottawa, IFACCA is the first global network of national arts funding bodies. Its chief aim is to create an international resource and meeting ground for all public bodies responsible for supporting excellence and diversity in artistic endeavour.

IFACCA's increasingly widespread membership is made up of national arts councils and ministries of culture. We encourage all those who support IFACCA's aims to become affiliate members of this exciting initiative and enjoy the unique advantages the Federation offers.

## Description of 'affiliates'

Affiliate members comprise:

- 1. Organisations** committed to public support for the arts, including public or private institutions involved in advocacy, policy or research about arts and culture, and public or private arts funders, foundations and endowments; and
- 2. Individual** professionals with expertise relevant to IFACCA's objectives who are *not* employed by or involved with an organisation that could reasonably be expected to be an 'organisational' affiliate.
